Pursuant to Home Rule Charter Article II "The Council" Section 1 "Number, Selection and Term of Office"

"The Council shall be composed of a Mayor and eight Councilmembers. Councilmembers shall be nominated and elected by the voters in each of eight Council Districts and the Mayor shall be elected by the qualified voters of the entire City. "...No person shall be elected to more than two consecutive regular four-year terms as Mayor. No person shall be elected to more than four consecutive regular two-year terms as a Councilmember. Any reference to Councilmember in this Charter shall mean Council/men/women."

CANDIDATE ELIGIBILITY REQUIREMENTS & DEADLINE TO FILE

Candidate Eligibility Requirements	Deadline to File Candidate Application
<p>A Candidate must:</p> <ol style="list-style-type: none"> (1) Be a United States Citizen. (2) Be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable. (3) Be a qualified voter of the State of Texas and the City of Pasadena. (4) Not been determined mentally incompetent by a final judgment of a court. (5) Not been finally convicted of a felony from which not pardoned. (6) Resided continuously in the City and the State for 12 months. (7) Must physically reside within the District he/she represents for a period of twelve (12) months immediately preceding the day of the election at which he/she is elected. 	<p>February 12, 2027 by 5:00 p.m.</p>
