We further understand that the temporary gas utilities may be disconnected for any violation of the building code. The general contractor and owner hereby assume responsibility for any violation of any ordinance by any sub-contractor.

Temporary gas permit may only be obtained when plumbing final inspection has been completed and also with the approval of authority having jurisdiction.

Temporary gas permits are in force for ninety (90) days only. If more time is required to complete the building, a new application for temporary utilities shall be submitted by a licensed plumbing contractor and be accompanied by the temporary plumbing permit fee.

The undersigned hereby severally agrees to indemnify and hold harmless forever the City of Pasadena, its officers and employees, from any and all claims or causes of action alleged to have been caused directly or indirectly by the temporary use of the utilities for which this application is made.

We hereby agree to abide by all provisions of the building code and this agreement.
